



ALMONTY ACHIEVES POSITIVE EBITDA FROM MINING OPERATIONS OF \$3,263,000 IN Q3 OF FY 2019

Toronto – August 14, 2019 - Almonty Industries Inc. (“Almonty” or the “Company”) (TSX: AII / OTCQX: ALMTF / Frankfurt: 1MR) today announced the filing of its unaudited interim condensed consolidated financial statements and management’s discussion & analysis for the three and nine months ended June 30, 2019. Unless otherwise indicated, all currency amounts contained in this news release are expressed in Canadian dollars.

Lewis Black, Chief Executive Officer of Almonty commented, “The Company’s outlook for the 2019 year is still positive, even with the dramatic 33% decline in tungsten prices. During the nine months ended June 30, 2019, we accomplished further long-term debt reductions totaling \$5.2m or 10.3% and reduced accounts payables and accrued liabilities by a further \$10.2m or 39.8%. We are continuing to advance our Valtreixal property in Spain, finalizing the planning for relocating the Los Santos processing plant to Valtreixal, commence a 10 year forward mine development plan at the Panasqueira mine and continue to develop our Sangdong Mine project in South Korea. As we have recently published on our website, work continues at our 100%-owned Sangdong project. The pilot plant is commissioned after some changes we made to the layout and it has begun to produce commercial grade finished concentrate. There is currently over 5,000 tons of fresh ore now on surface which is increasing as our mine development continues. We have passed the 350m mark in our mine development program underground and this continues to confirm the conservatism of our block models. We continue to move forward toward the closing of the previously announced financing for Sangdong as we recently announced final acceptance of the due diligence report and consequent green light from the KfW-IPEX Bank which coincided with the news of the mechanical completion and commencement of the pilot plant commissioning. We believe Almonty is well placed to remain the dominant Western supplier of tungsten concentrate.”

About Almonty

The principal business of Toronto, Canada-based Almonty Industries Inc. is the mining, processing and shipping of tungsten concentrate from its Los Santos Mine in western Spain and its Panasqueira mine in Portugal as well as the development of its Sangdong tungsten mine in Gangwon Province, South Korea and the development of the Valtreixal tin/tungsten project in north western Spain. The Los Santos Mine was acquired by Almonty in September 2011 and is located approximately 50 kilometres from Salamanca in western Spain and produces tungsten concentrate. The Panasqueira mine, which has been in production since 1896, is located approximately 260 kilometres northeast of Lisbon, Portugal, was acquired in January 2016 and produces tungsten concentrate. The Sangdong mine, which was

historically one of the largest tungsten mines in the world and one of the few long-life, high-grade tungsten deposits outside of China, was acquired in September 2015 through the acquisition of a 100% interest in Woulfe Mining Corp. Almonty owns 100% of the Valtreixal tin-tungsten project in north-western Spain.
